Tax Relief Forms CHY2

We would like to remind parishioners that any one who has contributed the sum of €250 or more to the parish by means of standing order, cheque, weekly envelope plus Easter & Chrismas dues during 2009 can at no furthur cost to the taxpayer allow the parish as a registered charity to reclaim the tax paid on their donations. As a result of your genouristy last year we received just over €26,000 back from the

Revunue for which we are extramely grateful so if you would be willing to allow the parish to claim back the tax paid on your contributions last year and you are paying tax under the PAYE system please complete a CHY2 form.
